Subject: Price Announcement - Dates

Dear partners,

Standards & Pricing (S&P) is glad to announce new Fairtrade Minimum Prices and Fairtrade Premiums for **Dates**.

This decision extends the prices for **Dates from Tunisia to Algeria**, and introduces a "for processing" price for **Dates from Egypt**.

The new prices for dates are presented in the table below. The Fairtrade Premium is paid in addition to the price, whether it is the market price (which applies if it is higher than the Fairtrade Minimum Price), the negotiated price (negotiated to be higher than the Fairtrade Minimum Price) or the Fairtrade Minimum Price.
